Property owners are reminded that June 15, 2011, is the DUE DATE for Assessment Appeals And Property Tax Payments for property owners not on preauthorized payment plans.

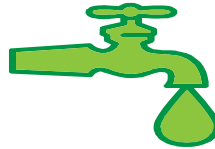
Monthly penalty-exempt pre-authorized property tax payment plans are available. Persons using this plan make twelve equal monthly or twenty-four bi-monthly payments instead of one annual lump sum payment on the tax due date.

WATERING BYLAW

The watering bylaw is effective May through September inclusive.

Odd-numbered houses:

6 am to 9 am and 7 pm to 11 pm
Wednesday, Friday, and Sunday

Even-numbered houses:

6 am to 9 am and 7 pm to 11 pm
Tuesday, Thursday, and Saturday

No outside watering between the hours of 9AM and 7PM

No outside watering on Monday.

Special 21-day permits are available at no charge once per year only, for exceptions to this policy for newly seeded or sodded lawns or other extraordinary circumstances which would allow watering outside the restricted hours.



As per bylaw, dogs must be leashed in public places, and owners must pick up after their dogs.
